Dear Friends,

At last we are able to issue the first “official” Cornerstone News for 2010, following Wayne’s accident in January this year. It has been a very difficult 5 months for us both. Wayne was discharged from Hampstead Rehabilitation Centre on 14<sup>th</sup> May, and we are now “house sitting” for Roz and Geoff Bond while they are in Port Macquarie until approx. early August. We are so thankful for the provision of a beautiful home in which to live over the next few months. Thank-you Roz and Geoff!!

## **Wayne’s progress:**

Wayne is now receiving “out-patient” Rehabilitation Treatment, involving Physiotherapy, Occupational-therapy, Hydrotherapy and sessions in the Gym spread over 3 mornings/afternoons each week, at the Hampstead Rehab. Centre. Progress is very slow, and unfortunately over the past 3 weeks, further hampered by “plantar fasciitis” in his right foot. The associated pain has made walking very difficult, even with a walking stick, so the wheelchair is vital at this stage. This was disappointing, as walking was really “going ahead” after his release from Hampstead. We Praise God for these wonderful facilities available here in Adelaide, and the people involved!

## **“Land Lease Title Deed Plan” & “Certificate of Title”:**

We received confirmation from our lawyer in Uganda, at the end of April, that both documents are now approved and only require our signatures to complete what has been a long and very frustrating process. Unfortunately the process requires our physical presence in Uganda to sign the final documents.

After waiting for 13 months the end is now in sight.

Upon our return to Uganda we will now be able to go ahead with submission of plans to Kitgum Town Council (KTC) for approval to commence construction of “permanent” buildings on the land.

## **Christine's Death, May 2010:**

In the September 2009 issue of "Cornerstone News" we told you about "Christine" (the wife of one of our workmen: Patrick).

We were notified recently that she passed away in late May. Though we expected this at some time, we still mourn with Patrick and their 4 beautiful children. Christine spent her last few weeks in a Hospice run by Irene Gleeson in Kitgum. We thank God for such a facility, bringing care and love to people in desperate need. Please continue to pray for Patrick and the children.

## **Uganda Update:**

Since Wayne's accident, Geoff and Hayley Smith from New Zealand have been overseeing the Cornerstone property at Oryang Ojuma. Geoff has been regularly visiting the land to supervise our three workmen, thus keeping them employed. He has also made sure that the Security Guards have been "keeping watch" over the property. We are again thankful to God for His provision of all that has been needed during our absence. Thanks Geoff & Hayley (and Jeremy). You are such a Blessing!

## **NGO Re-registration & Work Permits:**

NGO re-registration of CFA must be done during 2010 to enable our Work Permits to be renewed. This will mean that we need to return to Uganda to complete vital paperwork.

**We are still hoping to return later this year.**

Please pray for Wayne's recovery from his latest "set-back" (ie. Plantar Fasciitis), as these documents *must be completed this year* to enable the ministry of Cornerstone Foundation in Kitgum to continue.

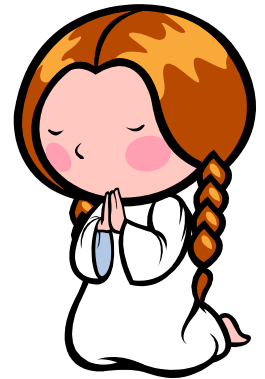
